Inspection Summary:

This review included evaluation of AltaGas' Maintenance and Inspection Procedures Manual (MIP), the Pipeline System Facility Manual (OM) and the Public Awareness Manual (PA).

During the review, procedures for reviewing operator's personnel during normal and abnormal operation to determine effectiveness of procedures (Items 93 and 110) were not found. Procedures were also missing from the MIP (MIP-409, MIP-202 and MIP-204). This information was sent to AltaGas on May 1, 2015, with corrections received from AltaGas on May 27, 2015. With corrections being made, there are no violations as a result of this procedures and plan review.
